

# DEAR FRIENDS,



As we reflect on fiscal year 2021, we want to express our deepest appreciation for the unwavering support of our amazing volunteers, our generous donors, and our dedicated staff who helped make this a remarkable year of growth even as we continued to face ramifications from the ongoing COVID-19 pandemic. For the first time in our program's history, CASA of Adams & Broomfield Counties became the largest serving CASA Program in Colorado! In total, we provided 635 children who experienced abuse and

neglect in the Colorado 17th Judicial District with the advocacy of a dedicated CASA Volunteer, a 12% increase over fiscal year 2020.

Of course, none of this work is possible without the extraordinary commitment of our many CASA Volunteers. In spite of the continued challenges and disruption of the pandemic, CASA Volunteers remained steadfast in their advocacy work, looking out for the best interests of the children on their cases and supporting them and their caretakers in a variety of ways. Including the 96 new CASA Volunteers that were recruited and trained, 289 CASA Volunteers served on 344 cases throughout the year.

In addition to successfully recruiting and retaining CASA Volunteers each year, the growth of the Program can be attributed to expansion of the Peer Coordinator Model. Peer Coordinators, experienced volunteers who step into a supervisory role, staffed 133 cases serving 219 children during the year. This remarkable volunteer commitment ensures our CASA Volunteers receive the supervision and support they need to be effective in their advocacy and allows our program to grow without incurring the exponential cost that would typically be associated

with serving more children. We are so grateful for our Peer Coordinators who are serving our CASA Program, CASA Volunteers, and children we work with!


At the same time our program was able to increase the number of children served, we also continued our work in diversity, equity, and inclusion, with a renewed focus on being a culturally responsive, equitable, and inclusive organization that better represents and serves the children and families we work with. We are pleased to report on the steps we have taken this past year to keep diversity, equity, and inclusivity central to our mission as we work to build a better future for children of all backgrounds in our community.

As we work for better outcomes for those children who have experienced abuse and neglect, we recognize data collection and evaluation help measure our effectiveness and guide program improvement. Protective factors such as consistent and caring adults and concrete supports during times of need counter the effects of adverse childhood experiences and increase children's resilience, educational success, health, and overall wellbeing long-term. We know that CASA Volunteers are these consistent and caring adults to many children in the child welfare system. Now, in collaboration with Colorado CASA and CASA Programs throughout the state, we have standardized and enhanced data collection and analysis to demonstrate how CASA Volunteers influence positive outcomes for children. Last year, nearly 94% of the children served by our program had the same CASA Volunteer from court appointment to case closure showing that CASA Volunteers are consistent, caring adults.

Thank you for all you do to support our mission to provide the critical services that can change a child's story!

As an organization that serves children and families of many different backgrounds and walks of life, we remain committed to Diversity, Equity and Inclusion (DEI).



# Karla serves as a CASA for a teenage

mom. The mom is from Honduras and has few people to depend on in the U.S. Her foster placement did not speak Spanish, and the teen was feeling alienated being in an unfamiliar place. Being bilingual herself, Karla has proved to be a crucial outlet for the teen to connect with, and the youth reaches out daily to Karla whether it is to talk about her feelings, her needs, and perhaps most important of all, her hopes for the future.

Advocate Supervisor Feliz Sanchez Garcia remarks "Karla's case is a great example of why Latinx and Hispanic volunteers are so vital. They not only bridge language barriers but cultural barriers as well. Karla has done an amazing job in bridging this gap and has played an integral role on this case."

### MUNICIPAL PARTNERSHIPS

Our CASA Program values the relationships we have with Adams County, Broomfield County, and the municipalities we serve. Their support is helping us move toward our goal of providing a Court Appointed Special Advocate for each child who needs one.

We especially want to recognize the City of Westminster, the City and County of Broomfield, and the Town of Bennett for their continued support of our CASA Program.

Through formalized partnerships, they are helping us to increase awareness about our organization, recruit more CASA Volunteers, and raise more funds so we can serve more children in the community.

These partnerships will have a positive economic impact on the future of our local counties, cities and municipalities. According to the 2013 Jim Casey Youth Opportunities Initiative Study, the direct future cost to the community for each child aging out of foster care is \$300,000. This is due to their increased risk of becoming incarcerated, experiencing homelessness and being unemployed.

When a stable adult, such as a CASA Volunteer, is in a child's life, those future risk factors can be drastically mitigated. It costs the CASA Program \$1,200 to provide a CASA Volunteer to one child for one year. Research shows that children with a CASA Volunteer are more likely to find a safe, permanent home, more likely to succeed in school, and half as likely to re-enter the foster care system.

Thank you to the City of Westminster, the City and County of Broomfield, and the Town of Bennett for recognizing the impact a CASA Volunteer can make on the entire community! We are so grateful for your unwavering commitment to the children and families in Adams and Broomfield Counties.







### **CASA RESPONDS TO COVID-19**

As the COVID-19 pandemic remains part of our daily lives, our CASA Program has continued to adapt to changing guidelines and restrictions, and in the process of addressing challenges has discovered new opportunities for sustainability and growth in our program.



#### **CASA Volunteer Activities**

As visits have moved back to in-person, CASA Volunteers are using virtual visits to supplement and increase contact with children and caretakers, enhancing the relationships that result in quality advocacy.



#### **Volunteer Recruitment**


Being forced to move information sessions, interviews, and training to a virtual environment was an initial challenge. In the end, we found that the flexibility these new platforms provide helped us expand our reach to new volunteers.



#### **Program**

Fundraising events were modified or canceled due to restrictions. We were able to secure COVID response grants from the Help Colorado Now statewide fund and from our municipal partners. In addition, we received a Paycheck Protection Program loan that converted to a grant as it was used to cover personnel expenses and retain our entire staff.

## **FY2021 BY THE BUDGET**



Caitlin and Dustin advocated for four children last year. Because of COVID restrictions, among other setbacks, the case had been in a holding pattern. Since the duration of the case had been under quarantine, the children had to complete school remotely for the majority of the year. The slow pace of the case combined with the prolonged separation from their parents, siblings, and friends was very tough for the kids; Caitlin and Dustin were sure to always be thoughtful of their situation, and made it their priority to help ensure the children had the resources they need to support their mental and emotional health. They checked in with their therapists, spent significant amounts of time going between all of their placements to visit, and even connected one of the children to educational resources to help them adjust to virtual learning. They made sure to talk to them about school, and their accomplishments, and

what they were experiencing.

### JOAN AND AERITH: A STORY OF RESILIENCE

At CASA of Adams & Broomfield Counties' 2021 Light of Hope event, we were able to give attendees a closer look into the story of Aerith, who found the love of a forever home after four placements and over 30 months in foster care. Aerith's past was one with abuse, neglect, and trauma, and both the adoptive mom and legal team worked hard to address her needs and provide her support during her time in the court system.

The CASA on the case, Joan, proved to be an especially important outlet for support. She formed a special bond with Aerith as she took her to movies, her soccer games, "ninja" classes, and always made sure to offer her hope for the future.

"I was there to support her, and she knew that," she said.

Aerith's adoptive mother, Jessi, remarked how "Joan was a break from the difficulties of foster care and finding a new family. And I saw how Joan saw her role as not only to advocate for Aerith in court but to support our family as a whole."

Judge Kathy Delgado, the Judge assigned to Aerith's case, also joined in the virtual event to share her unique perspective.

Aerith's adoption day was a day that made headlines throughout Colorado in 2019 when her entire third grade class packed into Judge Delgado's courtroom in celebration of Aerith's adoption. Right up front to celebrate with her was Joan.

When asked about Joan, Aerith said, "I'm pretty grateful for her because she was with me everywhere I went. She always helped. And if she wasn't here, a lot would be different right now."

Stories like Aerith's show us the inspiring resilience that children can possess, the importance of lifting these children during their search for their forever family, and the unique role a CASA Volunteer can play in providing support to strengthen families. We are grateful for Joan, Aerith, and Jessi for sharing their journey!

### **CELEBRATION AWARD WINNERS**

She maintained communication with the children's schools and forged a strong bond with the entire family. Even now that the court case has been dismissed, she maintains communication with the family. Beyond her work as a CASA Volunteer, she stepped up to support the organization in other ways by becoming a donor, translating resources into Spanish, and helping to spread the word about CASA in the community.

#### Marlene Wiske CASA Volunteer of the Year: CHARLES & ERIN KEYES

Marlene Wiske, a dear and devoted part of the CASA Family, passed away on October 31, 2016. Marlene dedicated 15 years of her life serving as a CASA Volunteer Advocate, and this award is in her honor. The recipients have inspired others, have made the time for deep engagement, and go above and beyond to change the odds of children in our community like Marlene did. Charles and Erin Keyes have exemplified everything we hope CASA Volunteers to be—passionate, dedicated, and willing to go above and beyond for the children they serve. Throughout their case they demonstrated relentless determination and a genuine desire to learn more about the CASA children and their family. The case ended in reunification and, as their Advocate Supervisor and Judge on the case would say, Charlie and Erin's advocacy was fundamental in the outcome.

#### Peer Coordinator of the Year: NATALIE MURPHY

The Peer Coordinator of the Year has already gone above and beyond by taking on this volunteer leadership role. They provide much needed support, resources, experience, and guidance to our CASA Volunteers. In recent years, the Peer Coordinator model has allowed us to reach new heights for how many children we are able to serve. Natalie is a compassionate leader and an enthusiastic ambassador for CASA and the work we do. She uses the knowledge and experience she gained serving on her own cases to coach and support her volunteers.

#### Judicial Officer of the Year: JUDGE PATRICK PUGH

This award is presented to a Judicial Officer that each and every day makes the toughest decisions about the future of the children involved in Dependency & Neglect cases. Judge Pugh is a Judicial Officer that our CASA organization values greatly for the regard he places on the insight of our Volunteers, as well as the passion and commitment he demonstrates to the children and families on his cases. From attending CASA Swearing-In Ceremonies to welcoming new CASA Volunteers in court and being a compassionate presence on the bench, his contributions to Adams County children and families do not go unnoticed.

#### Caseworker of the Year: JASMINE VAZQUEZ

These individuals are compassionate, hard-working, and committed to the children on their caseload and ensure that the CASA Volunteers assigned to their cases are involved with every step of the process. Jasmine provides immense support to the Volunteers that she works with and places a great amount of importance on their role. She has a genuine passion for her work and the children she is involved with.

#### **Guardian Ad Litem of the Year: DANA MILLS**

This award is given to a GAL who truly has the child's best interest in mind. The individual is passionate about their work and surpasses the expectations of a GAL. Moreover, a GAL is a line of defense for a child's immediate and long-term safety. Dana works tirelessly for the children on her cases and sees a clear value in CASA, frequently requesting Advocates for her cases and always making sure to keep the Volunteers she works with closely involved.

#### **CASA Board Member of the Year: DON TRIPP**

CASA's Board of Directors provides guidance and support to our program, staff, and volunteers. This award is presented to board members who have demonstrated outstanding service to the CASA program through the giving of their time, talents, and resources to further the goals and objectives of CASA of Adams & Broomfield Counties.
